To assist research into rheumatism and arthritis. *Applicants must be UK-registered medical practitioners and a member of the BMA.*

H C Roscoe – £65,000

To promote research into the elimination of the common cold and/or other viral diseases of the human respiratory system. *Applicants must be UK-registered medical practitioners or research scientists working in the UK.*

Helen H Lawson – £65,000

To promote research into end of life decision making. *Applicants must be UK-registered medical practitioners or research scientists working in the UK.*
